in downtown Akron was one of the many reasons he decided to join the firm.

"Buckingham was a very good fit for me because it will enable me to work in a collaborative environment and grow my practice," said Niekamp, who focuses on representing national banks in creditors' rights matters and small businesses in various aspects of corporate law. "It will also provide opportunities to the associates to grow their practices in downtown Akron. I will also be working out of the downtown office. I enjoy working downtown and am looking forward to downtown improvements when completed.

"I actually started my career at Buckingham and have worked with many Buckingham attorneys over the years," Niekamp said. "I have always been impressed by their professionalism, collegiality and legal acumen."

A native of Akron, Niekamp received his bachelor's degree in business from Miami University in Ohio and his juris doctor from Case Western Reserve University School of Law.

After spending a year at Buckingham, Doolittle & Burroughs, Niekamp joined Tramonte, Kot & Davis.

Prior to starting his law firm with attorney Mark Bernlohr in 2000, he was an associate at what is now Roderick Linton Belfance

"For most of my legal career, the setup has been 'eat what you kill,' so to speak," said Niekamp. "It was a great training ground because it taught me how to hus tle, work efficiently and manage my practice. "However, I got to the point where many of my clients needed additional expertise that was not available at my firm. I initially tried to grow the firm's practice internally by recruiting and training younger attorneys but found it difficult to retain good talent. Also, my growing clients had legal needs in the areas of labor law, intellectual property and litigation and Buckingham fortunately has great experienced attorneys in these areas of the law.

A resident of West Akron, Niekamp and his wife Andrea have three children. In addition to his work at Buckingham, he serves as the treasurer of the Akron Bar Association and president of the board of advisors for the Kohl Family YMCA in downtown Akron.

Former Niekamp, Weisensell, Mutersbaugh & Mastrantonio Of Counsel Carmen Roberto was planning on retiring when he received the offer to join Buckingham, Doolittle & Burroughs.

"My plan was to stop practicing at the end of 2020, but when I got this opportunity to serve as of counsel at one of the most respected law firms in the state I decided I had to take advantage of it," said Roberto, who focuses almost exclusively on criminal matters.

"My arrangement with Buckingham enables me to practice law while continuing my state, national and international bar work."

Born and raised in Hartford, Connecticut Roberto was initially planning to teach English at the college level. But after receiving his bachelor's degree from the University of Connecticut, he decided to go to law school.

While at The University of Akron School of Law, he joined the Army ROTC. After obtaining his juris doctor, he was stationed at Fort Benjamin Harrison Army post (now closed) in Indiana, where he served as a finance officer. He left the Army Reserves with the rank of captain. Roberto began his legal career as an associate at Miller and Morris. He then became an assistant municipal prosecutor for the city of Cuyahoga Falls. He worked for the city for approximately eight years and was promoted to assistant law director and then law director, a position he held for over four years.

In addition, Roberto is an exofficio member of the Ohio Lawyers Assistance Program and a former president of the Ohio Metropolitan Bar Association.

Roberto said he's really enjoying his new role at Buckingham.

"At this point, retirement is off the table for the foreseeable future," said Roberto. "As long as Buckingham has the need for my services I plan to keep practicing."

In the case of Pruneski, he became enamored with the legal profession at Girard High School.

"I enjoy working through problems and finding quick solutions to disputes whenever possible," said Pruneski, who focuses on business and real estate litigation. "I love the challenge of working with our clients to tell their story in the clearest and most convincing way."

Born in Youngstown and raised in the Trumbull County community of Girard, he majored in political science and economics at Youngstown State University, receiving his bachelor's degree in 1982. After graduating from Akron Law in 1985, he began his career at a small firm in the city.

In 1988, he joined the firm now known as Roderick Linton Belfance, where he became a partner and served as managing partner for seven years.

From 2000 to 2016, Pruneski was also the law director for the city of Green.

Prior to beginning at Buckingham, he was a sole practitioner for two years.

"I'm ecstatic to get the chance to work at Buckingham," said Pruneski. "They have a supportive and collaborative environment, where everyone works together to provide the best possible services to clients.

"I spent most of my career at a firm. When I opened my solo practice I really missed being able to discuss problems and issues with other attorneys.

Niekamp's former law firm.

"Our main Akron office is in Fairlawn," said Dimengo. "However, for most of the firm's history we had a downtown Akron location, and this new office is a return to our roots so to speak. Some of us who've been here for many years missed being downtown and we believe the office is a good investment and will lead to further growth in downtown Akron."
